SMALL BUSINESS FUNDING APPLICATION

— SMALL BUSINESS FACADE GRANT



If your business meets the requirements below, you may be eligible for the Small Business Facade Grant. Grants, up to \$5,000, must be used to make improvements to the facade of your establishment. Grants are reimbursable, meaning once approved you will purchase supplies or services, submit receipts, and then receive a reimbursement check.

Grant Requirements:

1. Registered Business in Iowa

- a. Legal Business Structure (Sole Proprietor/LLC/S Corp/Etc)
- b. Proof of date that EIN was registered

1. Business is located within Muscatine City Limits

- a. If you are unsure if your business is within city limits, you can verify on the attached map

1. Use of Funds

- a. Must be used for business façade purposes
 - i. Façade: The face of the building, especially the principal front that looks onto a street or open space
 - ii. Examples for brick and mortar: Signage, paint, door, windows, etc
 - iii. Example for home-based: Signage
 - 1. In order for home-based business to be eligible, business transactions must be made out of the home-where customers would physically be visiting the establishment and signage is a necessity to know where to go
 - 2. Grant funds to home-based business may **only** be used on signage, no cosmetic upgrades to the home itself.

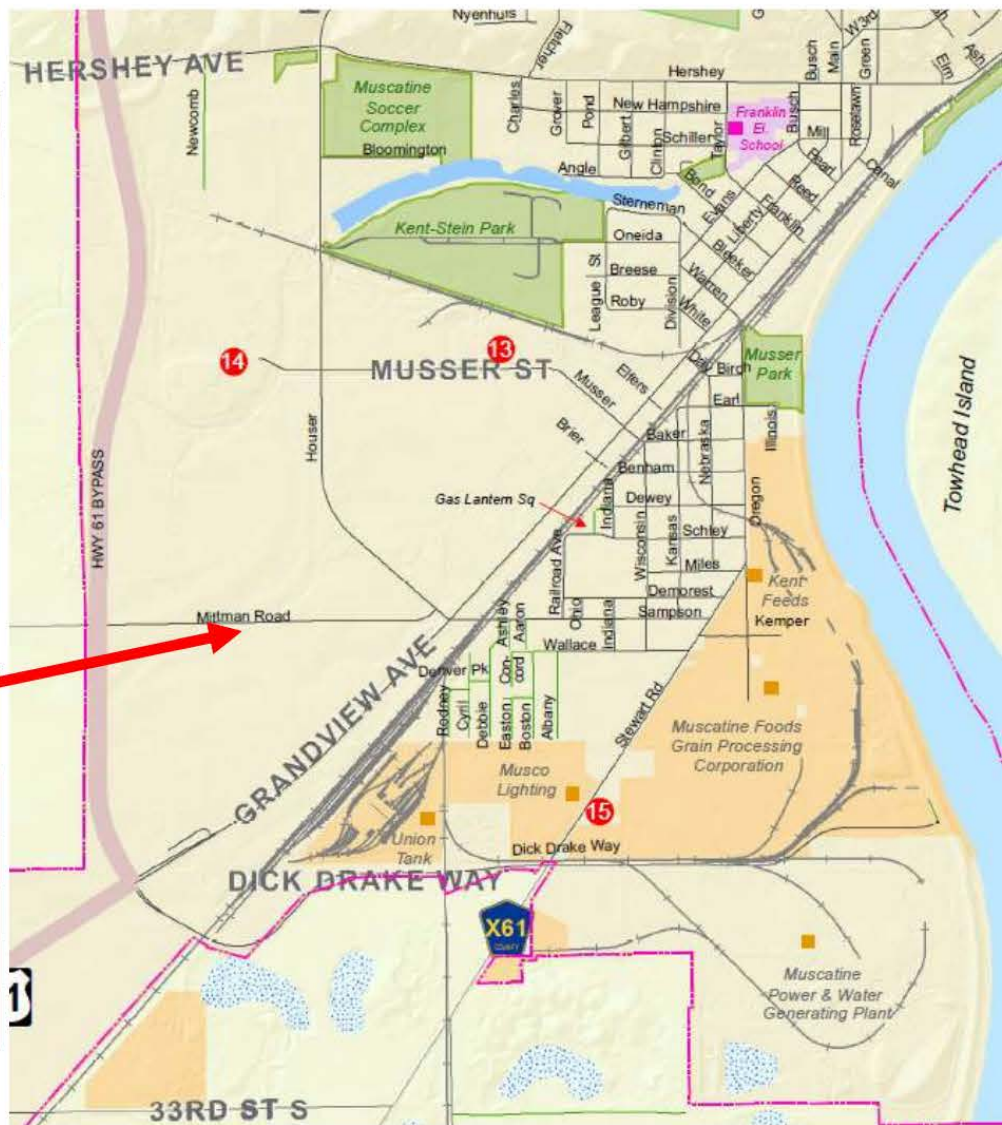
